7 AN ORDINANCE OF THE CITY OF LITTLETON,  
8 COLORADO, AMENDING TITLE 1, CHAPTER 14  
9 REGARDING LAND DEVELOPMENT IMPACT FEES

11 WHEREAS, the imposition of impact fees which are defined as land development  
12 fees under Colorado Revised Statutes is a financial matter and more appropriately placed in the  
13 administrative title of the City Code; and

14  
15 WHEREAS, the city is subject to the provisions of Title 29, Colorado Revised  
16 Statutes pertaining to the imposition of charges for land development as the legislature has  
17 exercised its power of preemption under the Colorado Constitution; and

18  
19 WHEREAS, the city intends that such fees only cover the full cost of capital  
20 facilities resulting from the development of new service units caused by new development and  
21 such fees are not intended to be a tax under the Taxpayer Bill of Rights in Article X of the Colorado  
22 Constitution; and

24 WHEREAS, the city council wishes to revise the capital facility impact fee rates.

27 NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF  
28 THE CITY OF LITTLETON, COLORADO, THAT:

30 Section 1: Subsection B of title 1, chapter 14 of the Littleton City Code is

**Section 2:** Severability. If any part, section, subsection, sentence, clause or phrase of this ordinance is for any reason held to be invalid, such invalidity shall not affect the validity of the remaining sections of this ordinance. The City Council hereby declares that it would have passed this ordinance, including each part, section, subsection, sentence, clause or phrase hereof, irrespective of the fact that one or more parts, sections, subsections, sentences, clauses or phrases may be declared invalid.

**Section 3:** Repealer. All ordinances or resolutions, or parts thereof, in conflict with this ordinance are hereby repealed, provided that this repealer shall not repeal the repealer clauses of such ordinance nor revive any ordinance thereby.
